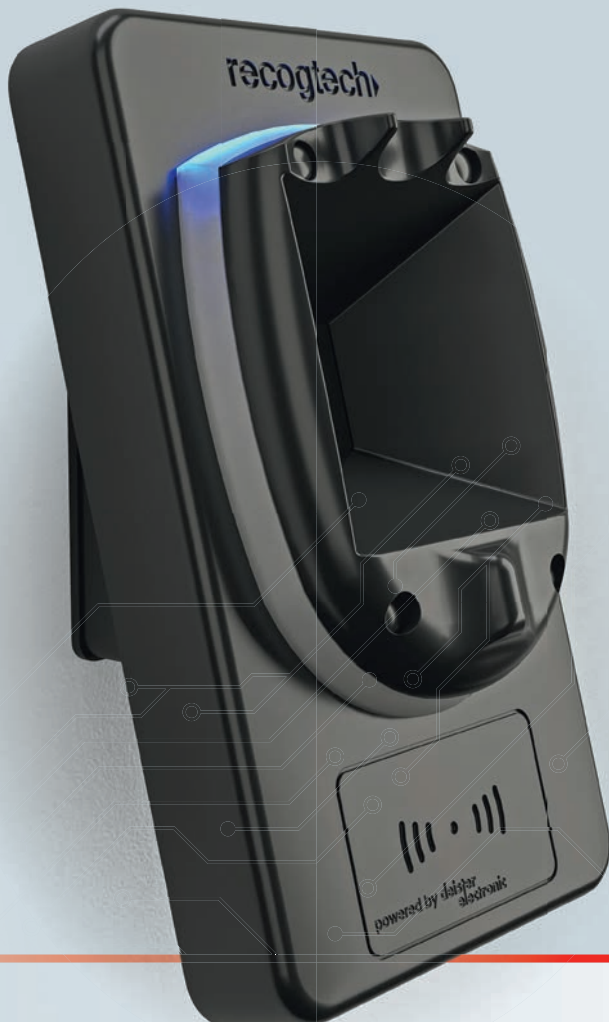
Recogtech's Palm-ID opens the door to the most effective, secure and rapid form of access control.

Within this context GDPR is becoming more and more significant. In 2018 case law relating to the protection of personal data inspired us to develop a solution that is GDPR compliant.
